
Basic information

- Documents not in the German or English language must be submitted with a certified German translation. A translation of the personal data page of the passport and your Dutch residence card are, however, not required.
- If you write your motivation letter and CV in German, than you have to explain how you learned German. Otherwise, please write your motivation letter and CV in English.
- The consulate reserves the right to request further documents.
- Missing documentation delays the procedure and can result in your application being rejected.
- Please do not contact the mission abroad to check the status of your application during the normal processing period. Such inquiries are extremely time-consuming for the visa section and can thus not be answered.
- Look at our <u>website</u> for the requirements for biometrical passport photos.
- An AU Pair contract must be with a minimum of 6 months and a maximum of 12 months.
- AU Pairs must have the age between 18 and 26 year old on the starting day of the AU Pair contract.
- You only can be AU Pair at a family, which speaks German in daily life at home.
- You need a language certificate from an accepted institute. We accept: Goethe-Institut, TELC,
 Österreichisch Sprachdiplom, TestDAF (only offers B2 or higher) und ECL Prüfungszentrum.
